**Important Instruction :**

1. According to Government Corrigendum No: Misc-2018/C.R.-56/18/UNI-I Dated 10/05/2019 it is binding on the college authorities to invite The Director, Higher Education or his nominee as a member of selection committee being a Government nominee, invariably.
2. Eligibility Conditions for Selection of Principal, Professor, Assistant Professor, Director of Sports, Librarian shall be as per UGC Regulations 2018 (Govt. Regulations 08 Maech, 2019).
3. Regarding the implementation of cadre-wise reservation policy for teaching posts in non-agricultural universities and affiliated colleges/institutions in the state as per the Maharashtra Educational Institutions (Reservation in Teaching Cadre) Act, 2021 shall be as per शासन निर्णय क्र. संकीर्ण-२०१९/प्र.क्र.९४/१९/विशि-१, दिनांक ११ एप्रिल, २०२२

4. RESTRICTIONS TO FILL UP THE VACANCIES :

- a) If the Vacancy arises due to retirement/Voluntary retirement/Resignation or Death on or after 1-3-2000 the vacancy shall be filled in with the prior approval of the Committee constituted by the Government of Maharashtra as per शासन निर्णय क्र. संकीर्ण २०१८/(४६११)/विशि-४, व क्र.बीजीटी १०००/प्र.क्र.-३/अर्थसंकल्प-१९, दिनांक २९ जून २०००.
- b) When a vacancy arises and remains vacant for more than six months the vacancy shall be revived through the committee constituted by the Govt. of Maharashtra as per G.R. No. शासन निर्णय क्र. बीजीटी १०००/प्र.क्र.-३/अर्थसंकल्प-१९, दिनांक २९, जून २०००.
- c) The above restrictions (a) & (b) are not applicable if the vacancies are to be filled in to fulfill the backlog as per the above शासन निर्णय क्र. बीजीटी १०००/प्र.क्र.-३/अर्थसंकल्प-१९, दिनांक २९, जून २०००.
5. The date of the interview may please be fixed in consultation with V.C.Nominee & concerned members well in advance. It may please be noted that T.A. & D.A. will be paid to the members by the college authorities.
6. As per Statute 167 (1),(f),(vi) immediately after conclusion of selection committee meeting, the proceedings of the selection committee, relevant information and documents shall be sent to the University within two days for approval and only after receipt of the approval, the management shall appoint the Teacher(s)/Principal, strictly as per the approval of the University.
7. As per statutes 167 (i) (f) (xii) while forwarding the proposals to the university for approval of the appointed candidate to the post of Principal/Lecturer it shall be sent along with the following documents to the The Registrar / Dy. Registrar, Academic Approval Section, S.R.T.M.University, Nanded.
- i) Original reports of the Selection committee.
- ii) True copies of the marks memoranda of graduate and Post-graduate examinations as well as postmasterate level qualifications, if any, in respect of the candidate recommended by the selection committee.
- iii) The names of News papers in which the advertisement was published together with Xerox copies of cuttings of the advertisement.
- iv) Certified copies of caste certificates & caste validity certificates in respect of candidates belonging to the reserved category.
- v) The list of the candidates (Full name) to who call letters have been issued along with the signatures of the candidates who were present to the interview.
8. In absence of Subject Expert nominated by the Vice-Chancellor, the interview should not be conducted, The college should ask to the University for new subject expert along with the copies of the correspondence made to the earlier Subject Expert.
9. If any nominated member is retired while the processes of interview, don't allow such member to conduct the interviews.
10. As per Statute S.167(viii) The management, after receipt of the approval of the university shall appoint the Principal / Vice-Principal / Teachers strictly as per the approval of the University.
